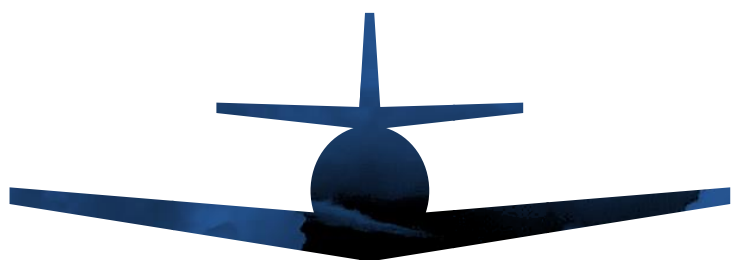

1 - Purpose

The purpose of this Guernsey Advisory Circular is to make public the opening hours and contact details for inspecting the registers maintained by 2-REG on behalf of the Aircraft Registrar.

2 - Related laws and regulations

This Guernsey Advisory Circular relates to:

- 2.1 The Aviation Registry (Guernsey) Law, 2013, sections 10(1) and 10(6); and
- 2.2 The Aviation Registry (Fees) Regulations, 2018.

3 - Definitions

Definitions, in the context of this GAC shall have the meanings listed in GAR Part 1 (Definitions, Abbreviations and Units of Measurement).

4 - The Registers

The following registers are available for inspection by the public:

- The Aircraft Register;
- The Engine Register;
- The Charges Register.

5 - Days and hours for public inspection

The registers maintained pursuant to section 10(1) of the law referred to in section 2.1 above are open for public inspection during normal weekdays from 10:00 to 16:00 hours. By prior telephone arrangements, another time for inspection may be arranged.

6 - Telephone and e-mail contact information

7 - Location

The offices of the Aircraft Registrar and of the Guernsey Aircraft Register are co-located at the following location:

Upon request, copies or extracts of entries in the Registers will be supplied certified or uncertified.
